

# RELIANCE PLASTIC APPLIANCE CONDITIONER

**INDICATIONS FOR USE:** The **Reliance Plastic Appliance Conditioner** is intended for use as a conditioner of plastic brackets or acrylic appliances in preparation for bonding with any adhesive, sealant or cement. It can also be used to condition a composite restoration or acrylic jacket prior to bonding and to rebond a bracket impregnated with adhesive.

#### **INSTRUCTIONS FOR USE:**

#### BONDING A PLASTIC BRACKET OR ACRYLIC APPLIANCE:

With a brush or sponge pellet, apply a thin uniform coat of **Reliance Plastic Appliance Conditioner** to the plastic surface to be bonded. Wait at least 60 seconds before applying the bonding paste.

#### BONDING TO A COMPOSITE RESTORATION:

With a fine diamond, lightly abrade the composite to remove the shine. Clean area with an air syringe. Using a sponge pellet or brush, apply a thin uniform coat of **Reliance Plastic Appliance Conditioner** and allow to dry. Apply a thin coat of bonding resin to the conditioned composite surface and the paste to the bracket. Place bracket on tooth and position. If Rely•a•Bond® is the adhesive of choice, apply the Rely•a•Bond® Primer to the conditioned composite and the bracket base. Apply the paste to the bracket base, place the bracket on the tooth and position.


#### NOTE: A NEW APPLICATOR IS REQUIRED FOR EACH PATIENT
